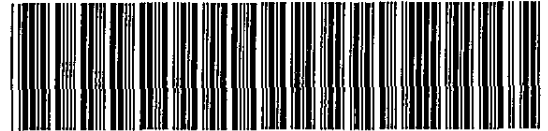

ARTICLE I
COMPANY NAME

ARTICLE VII
MANAGEMENT

The Company shall be a member managed Company.


ARTICLE VIII

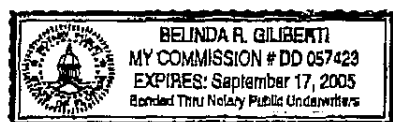


