## ARTICLES OF ORGANIZATION

OF

## ARTICLE I

#### NAME AND ADDRESS

The name of this Limited Liability Company shall be Dilks Properties 1266 Martinique, LLC (the "Company"). The mailing address and street address of the principal office of the Company is 854 Fairlawn Court, Marco Island, Florida 34145.

### LIMITATIONS ON MEMBERS

The Members shall not take any action on behalf of this Company that is prohibited by the Florida Limited Liability Company Act, or any action that requires consent of the other Members of the Company without first obtaining the prior written consent of all Members of the Company.
