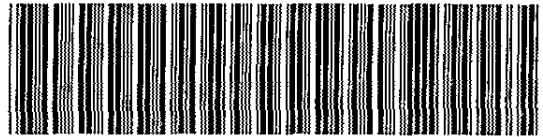

### **ARTICLE I Name**

**Members Rights to Continue Business**

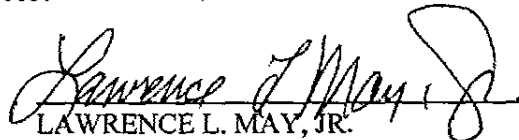

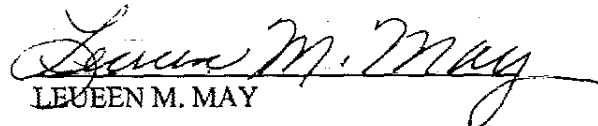
