#### ARTICLES OF ORGANIZATION

#### **OF**

## PALM BEACH PSYCH. SERVICES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

#### ARTICLE I

#### Name
