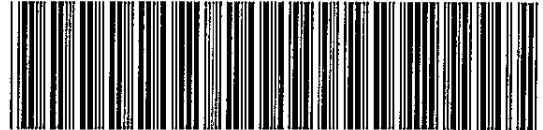



1. Name. The name of the limited liability company is Translation & Interpreting Group, LLC.


