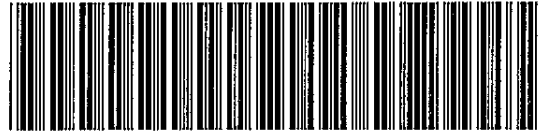

The name of the limited liability company shall be Collingwood Construction Group, LLC ("Company").


4. These Articles of Amendment to Articles of Organization were duly adopted by the unanimous vote of the Members and the Managers of this limited liability company on January 31, 2006
