

ARTICLES OF ORGANIZATION OF JEWELRY & WATCH EXPRESS OF SANTA ROSA MALL, LLC

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I

NAME

The name of the Limited Liability Company is: Jewelry & Watch Express of Santa Rosa Mall, LLC.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the Limited Liability Company is: 300 Mary Esther Blvd. #46, Mary Esther, FL 32569.

ARTICLE III

REGISTERED OFFICE AND AGENT
