
ARTICLE IX



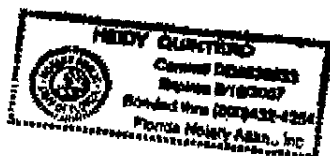


