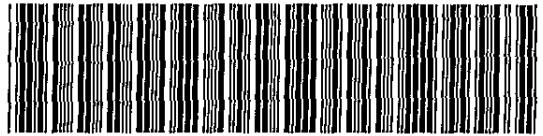





**ARTICLE V**
