





AMENDED & RESTATED ARTICLES OF ORGANIZATION
OF

Pursuant to Section 608.407 of the Florida Statute

First: The name of the limited liability company is: **GALIANO TRADE LTD.CO.** Registry Number: L03000037471, registration date: 24th day of October, 2003 a limited liability company organized under the laws of the State of Florida, US.
