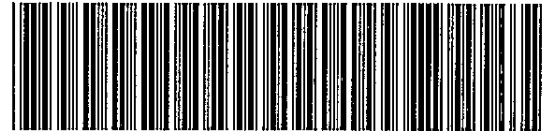



6. The business and affairs of the Limited Liability Company will be managed


