TO
ARTICLES OF ORGANIZATION

SECOND: The date of filing of the Articles of Organization was October 1, 2003.

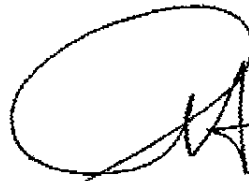
