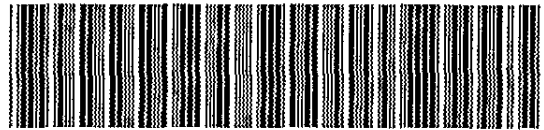

**ARTICLES OF ORGANIZATION  
OF  
VOLUSIA PROPERTIES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **VOLUSIA PROPERTIES, LLC** ("Company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company shall be 3280 S. Atlantic Avenue, Suite A, Daytona Beach Shores, Florida 32118.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company shall have perpetual existence, unless earlier terminated in accordance with the provisions of this Agreement.
