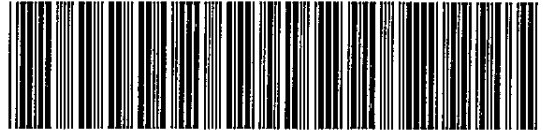



Name**
