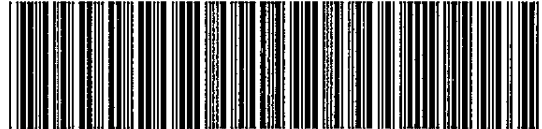

**NAME**
