**ARTICLES OF DISSOLUTION

Pursuant to Section 608.441 of the Florida Limited Liability Company Act (the "Act") and the Company's Operating Agreement, the majority of the Members of DPMD, LLC submit these Articles of Dissolution to the Florida Department of State:

1. The name of the limited liability company is DPMD, LLC (the "Company").
2. The Articles of Organization were filed with the Florida Department of State on October 7, 2003 and assigned Document Number L03000038280.
3. The date the dissolution was approved by the majority of the Members was December 1, 2010.
4. The dissolution was the result of the written consent of the majority of the Members, pursuant to Section 608.441(c) and the Company's Operating Agreement.
5. All debts, obligations and liabilities of the Company have been paid or discharged, or provisions have been made pursuant to Section 608.4421.
6. All remaining property and assets have been distributed to the Members in accordance with their respective rights and interests.
7. There are no suits pending against the Company in any court.
