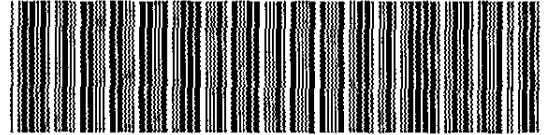

ARTICLES OF ORGANIZATION

OF

TUNNEL MASTER CUSTOM METAL WORKS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **TUNNEL MASTER CUSTOM METAL WORKS, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 14622 Northwest 174th Lane, Alachua, Florida 32615 and the mailing address shall be Post Office Box 1575, Alachua, Florida 32616.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.


