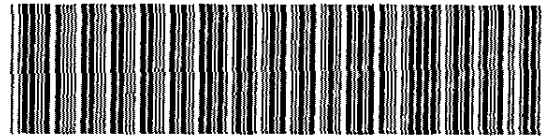

FIRST: The Articles of Organization were filed on 10/02/03 and assigned document number L03000038303


SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:
