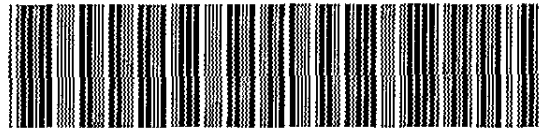

ARTICLE V - Admission of Additional Members:


The right, if given, of the member to admit additional members and the terms and conditions of the admissions shall be upon the unanimous written consent of the then existing members.


