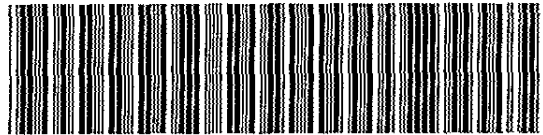

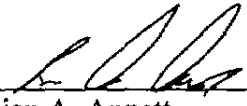
ARTICLE V — Limitation on Agency Authority of Members:

ARTICLE VI — Operating Agreement

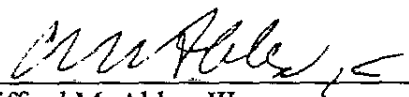
