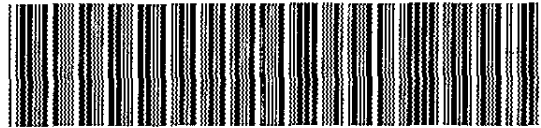



ARTICLES OF ORGANIZATION
OF

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Limited Liability Company shall be STRATEGIC RESTAURANT CONCEPTS, LLC, and its principal office shall be located at 764 Grand Parke Drive, Jacksonville, State of Florida, but it shall have the power and authority to establish branch offices at any of the place or places as the members may designate.
