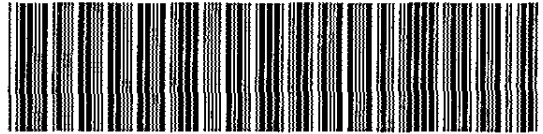

The name of the limited liability company shall be SCHARDT PROPERTIES, LLC.

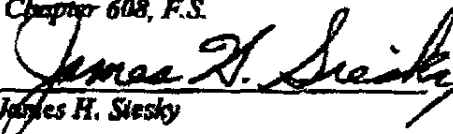
ARTICLE 2: PURPOSE
