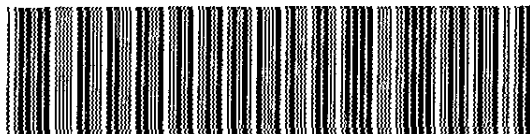



SECOND: The period of its duration shall be perpetual.


THIRD: The mailing address and street address of the principal office is 2806 Valencia Way, Fort Myers, FL 33901.

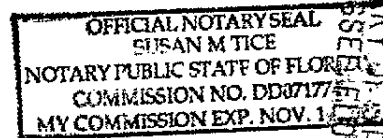
