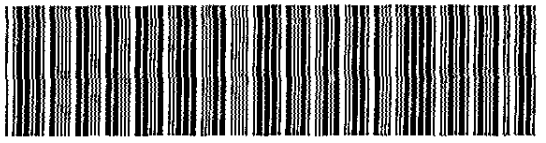

**Articles of Organization for Professional Limited Liability Company
For
Linda "Bunny" Speidel, L.C.**

In compliance with Chapter 608 and Chapter 621, Florida Statutes, the undersigned subscriber(s) to these Articles of Organization, being duly licensed to practice real estate brokerage under Chapter 475, Florida Statutes, hereby adopts these articles of organization to form a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, and other applicable laws of the State of Florida.

Article I – Name

The name of the professional limited liability company is: **Linda "Bunny" Speidel, L.C.**

Article II – Principal Office

The principal office and mailing address of the corporation is: 782 109th Avenue North, Naples, FL 34108.

Article III – Purpose

The purpose for which the limited liability company is organized is to engage in every phase and aspect of the practice of real estate brokerage as defined in Chapter 475, Florida Statutes. In addition, the corporation may (a) join in other professional service corporations, limited liability companies or business entities similarly engaging in said practice of real estate brokerage, (b) invest its funds in real estate, mortgages, stocks, bonds or any other type of investment, and (c) own in its name real property or personal property necessary or proper for the rendering of real estate brokerage services.

Article IV – ~~Capital Stock Shares~~ Membership Unit Certificates

The ownership interests in the professional limited liability company shall evidenced by 1,000 membership unit certificates, without par value.

None of the membership unit certificates may be issue to anyone other than other an individual duly licensed to practice real estate brokerage in the State of Florida or a professional service corporation, limited liability company or other business entity similarly restricted to engaging in the practice of real estate brokerage.

Article V – Management

Article VII – Restraint on Alienation of Shares

The members of the professional limited liability company shall have the power to include in the operating agreement for the company, or by separate agreement adopted by a majority of said members, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding membership unit certificates by any of its members or in the event of the death of any of its


members. No member of the company may sell or transfer any membership interest in the company except to another individual or entity eligible to be a member of this professional limited liability company, and said sale or transfer may be made only after it has been approved by all members of the company at a meeting of the members called for that purpose. If any member of this company becomes legally disqualified to practice real estate brokerage in the State of Florida, is elected to public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services by the member, that member's membership unit certificate(s) shall immediately become subject to purchase by the professional limited liability company in accordance with the operating agreement or resolutions adopted by the remaining member(s).
