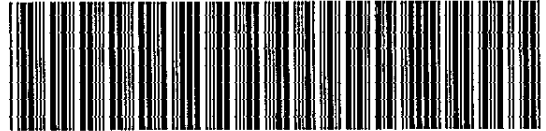




ARTICLE IV - DURATION
