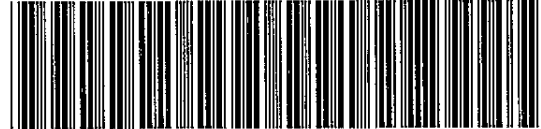

"Article I

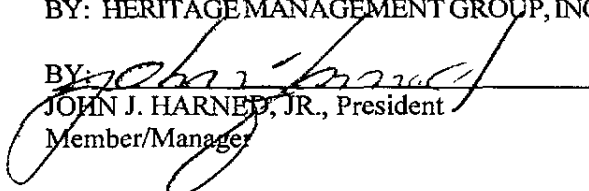
The name of the Company shall be HERITAGE EQUIPMENT LEASING, LLC"

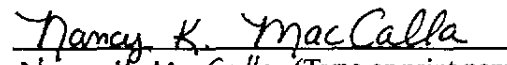

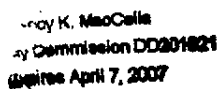
