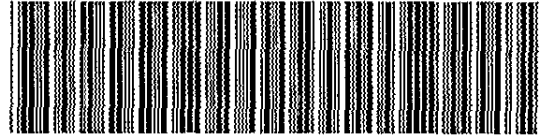

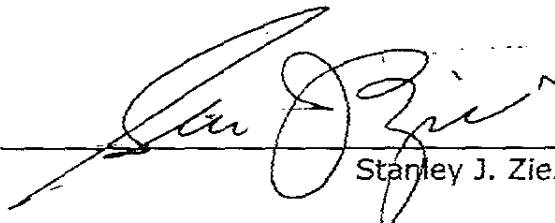
**ARTICLE VII – Amendments:**
