

ARTICLES OF ORGANIZATION OF IIFGCF, LLC

BONE STATE The undersigned, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company shall be JJFGCF, LLC ("Company").
