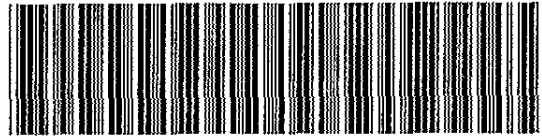

Transfer of Member's Interest

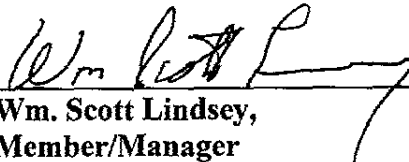

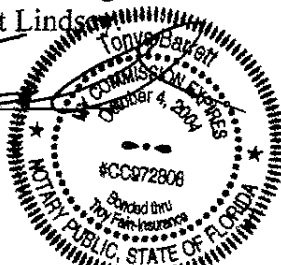

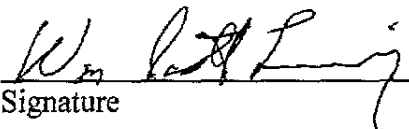
