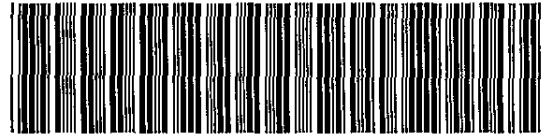

ARTICLES OF ORGANIZATION

OF

BRIARPATCH I LLC

THE UNDERSIGNED, JERRY JOHNSON and GAIL JOHNSON, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the limited liability company shall be BRIARPATCH I, LLC, ("Company"). The principal office of the Company in Florida shall be: 13101 Ponderosa Way, Fort Myers, Florida 33907.

ARTICLE II - MAILING ADDRESS

ARTICLE III - DURATION

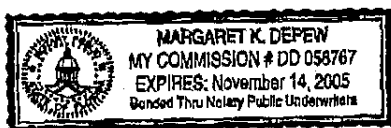
