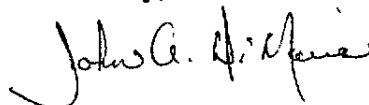

THE BESCORE PURCHASING GROUP, LLC**

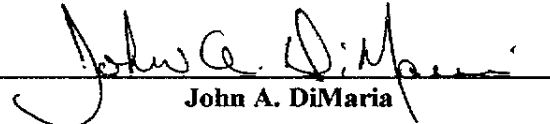
1. The Name of this limited liability company is THE BESCORE PURCHASING GROUP, LLC (the "Company").

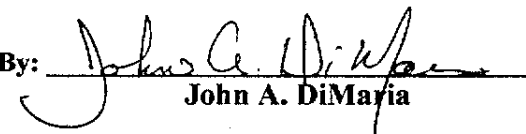
