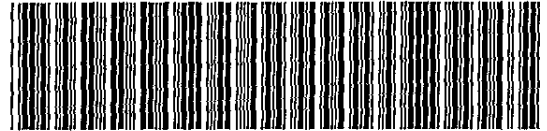

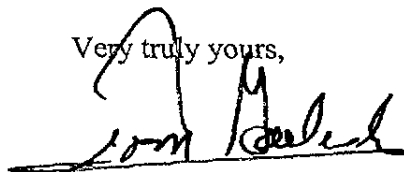

**ARTICLES OF ORGANIZATION**

1. Name. The name of this limited liability company is Wooly Bugger, LLC, a Florida limited liability company (the "Company").
