ARTICLES OF ORGANIZATION FOR UNITED SOAP FACTORY, LLC

The undersigned being the authorized representative of a member of the limited liability company referred to herein, executes and files these Articles of Organization and states as follows:

ARTICLE I - NAME

The name of this limited liability company is UNITED SOAP FACTORY, LLC.

ARTICLE II - EFFECTIVE DATE AND DURATION

This limited liability company's duration shall be perpetual.

ARTICLE III - PURPOSE AND POWERS
