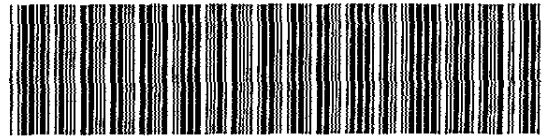

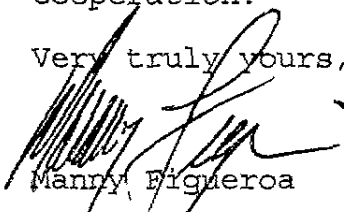

The Company is to be managed by its Managing Members, John Marshall, Jorge P. Amaya, and Xavier Anton.

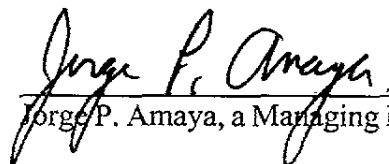
ARTICLE VI C Limitation on Agency Authority of Members:
