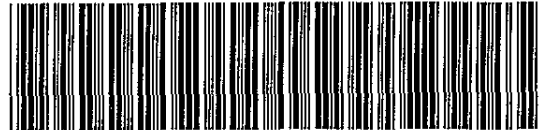

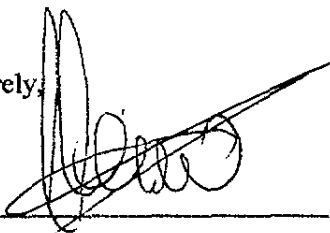

1. The name of this limited liability company is **LANDER GROUP TECHNOLOGY AND SERVICES, LLC** (the “ Company”).
2. The Company is being formed for the following purposes:

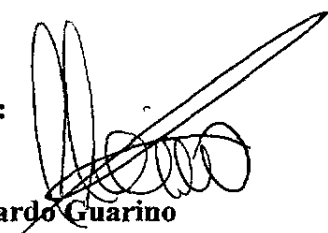

Further, the power to adopt, alter, amend or repeal the Company's operating agreement shall be vested in the Company's members.
7. The Company shall indemnify any and all of its manager, officers, employees or agents former officers, employees or agents or any person or persons who may have served at its request as a manager, officer, employee or agent of another company, corporation, partnership, joint venture, trust or other enterprise in which it owns an equity interest or of which it is a creditor, to the full extent permitted by law. Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgments, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceedings, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or his legal representative may be made a party or may be threatened to be made a party, by reason of this being or having been a manager, officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any member, manager, officer, employee or agent may be entitled as a matter of law or which he may be lawfully granted.
