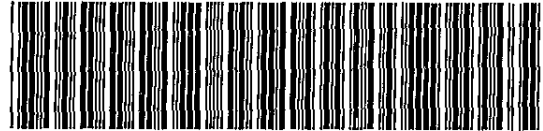

**ARTICLE I**

The name of the limited liability company shall be Senator Development, LLC.


