**ARTICLES OF ORGANIZATION

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

Management of the Company


The Company shall be managed by one or managing members, who shall be elected annually by them members in the manner set forth in the Company's Operating Agreement.


