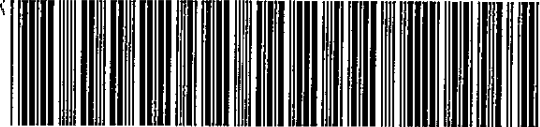

**First:** The articles of organization were filed on October 20<sup>th</sup> 2003 and assigned document number L03000040163

**Second:** The following amendments to the Articles of Organization were adopted by the Lee Cancer Clinic a Professional Limited Liability Company:

**Article 6**

**Duration:** the company shall exist perpetually

**Article 7**

**Management:** This Company shall be managed by

A) Bhanuprasad Koneru MD, 4755 Summerlin Rd, Suite 7, Fort Myers, FL 33919

B) Robert Schwartz MD, 3677-D Central Ave, Fort Myers, FL 33901

All the powers of the limited liability company shall be exercised by or under the authority of the managers of the limited liability company. The board of managers may consist of a number of persons elected to the board as prescribed in the operating agreement of the limited liability company.

**Article 8**

**Membership:** The above named Lee Cancer Clinic, professional limited liability company has at least two members. Additional members may be admitted to the limited liability company upon approval by the board of managers.
