ARTICLES OF ORGANIZATION

OF

These Articles of Organization of Advanced Imaging Associates, LLC (the "Company"), have been duly executed and are being filed by the undesigned member to form a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608) as follows:

ARTICLE I NAME

The name of the limited liability company formed hereby ADVANCED IMAGING ASSOCIATES, LLC.

ARTICLE II ADDRESS
