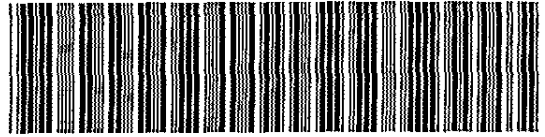

The mailing address and street address of the principal office of the company is 4417 Calienta St., Hernando Beach, FL 34607.






