ARTICLES OF ORGANIZATION
OF
PRIME E M, LLC**

The undersigned member hereby executes these Amended and Restated Articles of Organization for the purpose of forming a limited liability company in accordance with Chapter 608, Florida Statutes, and to be effective as of the date of filing with and approval of the Articles of Merger between Prime E M, LLC ("Prime, LLC") and Prime Equestrian Management, Inc., a Florida corporation ("Prime, Inc.") (with Prime E M, LLC, being the surviving entity) by the Florida Department of State (the "Effective Date")

ARTICLE 1

Name

The name of this limited liability company shall be: PRIME E M, LLC.

ARTICLE 2

Mailing Address and Street Address
