**FIRST:** The date of filing of the articles of organization was October 21, 2003

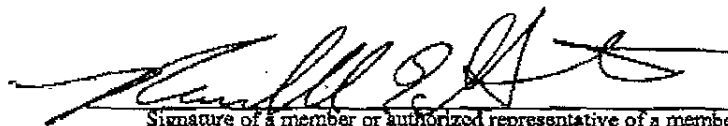
**SECOND:** The following amendment(s) to the articles of organization was/were adopted by the limited liability company:
