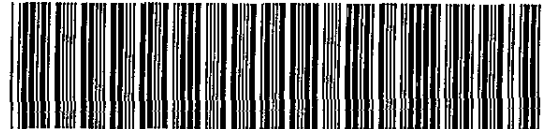



**ARTICLES OF ORGANIZATION
OF
FAB METAL SERVICES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be FAB METAL SERVICES, L.L.C.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 735 AirPark Road, Unit 4 and 10, Edgewater, Florida 32132.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the regulations.

ARTICLE IV - REGISTERED OFFICE AND AGENT

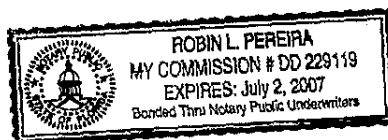
