The name of the Company is J & N VENTURES, LLC

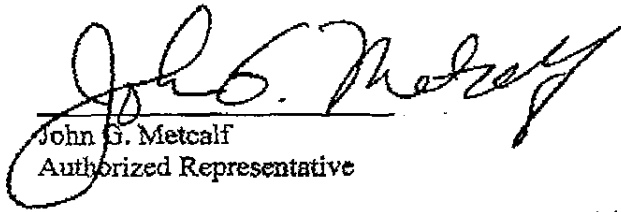
