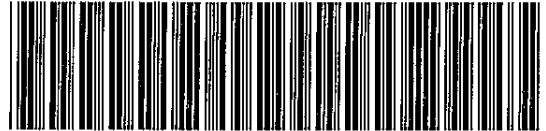


ARTICLE FIVE - ADMISSION OF NEW MEMBERS
