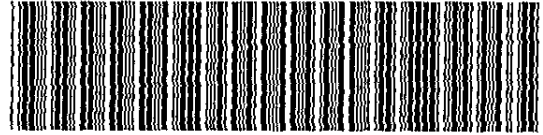

Members have the absolute right to continue said organization in perpetuity even after the dissolution of any of the members, provided that the geal minimum number of members remains in the organization.






