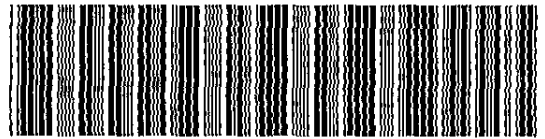

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be Southwest Florida Boat Store, L.L.C. ("Company").

**ARTICLE II - PURPOSE AND POWER**

**ARTICLE IV - INITIAL REGISTERED AGENT AND REGISTERED OFFICE**






