ARTICLE VI  
Admission of Additional Members:

In the event a new Member is added by such amendment, it shall be also signed by the Member to be added.

ARTICLE X  
Regulations of Company

The power to adopt, alter, amend or repeal the Regulations of the Company shall be vested in the Members, by any amendments of the Articles of Organization. Regulations adopted by the Members may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager.


ARTICLE XII

Transferability of Member's Interest


An Interest of a Member in this Company may be transferred or assigned only to such extent and in the manner provided in the regulations and Operating Agreement.


