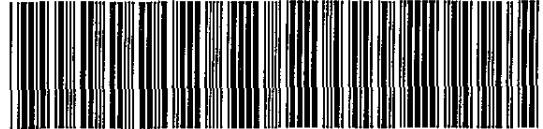

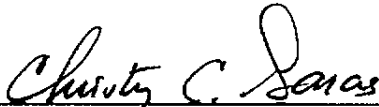
## **ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS**
