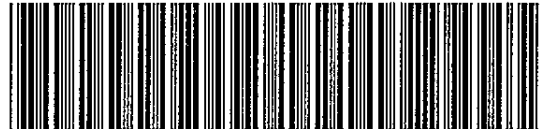



The Limited Liability Company may indemnify the Members or former Members to the full extent permitted by law and the Operating Agreement.


Article 8. Admission Of Additional Members.

Article 9. Amendment

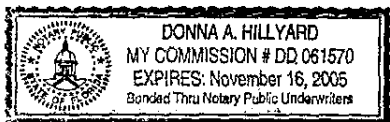


